Org .Setting And Reporting

The United Nations Human Settlements Programme, UN-Habitat, is the agency for human settlements. It is mandated by the UN General Assembly to promote socially and environmentally sustainable towns and cities with the goal of providing adequate shelter for all. The UN-HABITAT Public Information and Communication internship is for 6 months. The Internship is UNPAID and full-time. Interns work five days per week (35-40 hours) under the supervision of a staff member in the department or office to which they are assigned.

Responsibilities

Daily responsibilities will depend on the individual's background; the intern's assigned office as well as the internship period. Under the Overall supervision of the Chief of Tehran Office, the interns:

- provide support to the UN-Habitat office in organizing public information and Press events

- take photos and make videos during UN-Habitat events
- assisting UN-Habitat staff with website and social media maintenance
- assisting in managing the website
- Any other related task assigned by the Chief of Tehran Office Specific Tasks:

1. Writing skill:

- translate UN-Habitat news from English into Persian and vice versa
- writing stories, reports, web pages and news both in English and Persian
- transcribe and translate UN-Habitat films

2. Media monitoring/press clippings and social media:

- review local media and contribute to preparation of press clippings
- monitor media coverage of the UN-Habitat activities in Iran
- contribute to the updates of the UN-Habitat Iran social media platforms

3. Research:

- contribute to the content for updating the bilingual www.unhabitat.org.ir website
- research and compile new materials
- 4. Design and photography:
 - Assist with design of UN-Habitat Tehran Office publications, promotional materials (Posters, Brochures,...)
 - Draft Press Releases
 - knowledge of editing and design software (Photoshop, illustrator, in-design, etc)
 - knowledge of some open source subtitling software
 - knowledge of info graphics and other multimedia software
 - ability to manage and edit website
 - preferably knowledge of web design

- b. Be enrolled in the final academic year of a first university degree program (minimum Bachelor's level or equivalent);
- c. Have graduated with a university degree and, if selected, must commence the internship within a one-year period of graduation. Be computer literate in standard software applications. Have demonstrated keen interest in the work of the United Nations and have a personal commitment to the ideals of the Charter; Have a demonstrated ability to successfully interact with individuals of different cultural backgrounds and beliefs, which include willingness to try and understand and be tolerant of differing opinions and views. Preferred area of study: Studies in Communication, Journalism, Social Science, Law, graphic design or computer science.

Work Experience

Applicants are not required to have professional work experience for participation in the programme.

Languages

English and French are the working languages of the United Nations Secretariat. For this internship, fluency in oral and written English and Persian is required. Knowledge of another UN Language is desirable.
