Org .Setting And Reporting

The United Nations Human Settlements Programme, UN-Habitat, is the agency for human settlements. It is mandated by the UN General Assembly to promote socially and environmentally sustainable towns and cities with the goal of providing adequate shelter for all. The UN-HABITAT Public Information and Communication internship is for 6 months. The Internship is UNPAID and full-time. Interns work five days per week (35-40 hours) under the supervision of a staff member in the department or office to which they are assigned.

Responsibilities

Daily responsibilities will depend on the individual's background; the intern's assigned office as well as the internship period. Under the Overall supervision of the Chief of Tehran Office, the interns:

- Assist the Chief of the Office in identifying projects related to urban planning and design, urban economy and employment, urban basic services, housing and slums upgrading, and land management
- Undertake desk research in the urban sector and urban management and related topics in Iran
- Assist in developing concept notes or proposals as well as technical terms of references
- Attend technical meetings with pertinent Government departments

- Translate technical documents from English to Persian and from Persian to English Assist in preparation of technical reports
- Assist in reviewing outputs (reports) generated by partner organizations
- Assist in developing communication and training materials
- Assist the National Habitat Committee and its coordinator in support of Habitat III Conference preparations
- If so applicable, source and review existing documentation on the latest concepts and policy directions as well as key international literature on the subject matter
- Assist in Analyzing various urban or related policies in the Islamic Republic of Iran, as well as current policy frameworks, to identify the strengths, challenges and areas for improvement and intervention by UN-Habitat
- Any other related task assigned by the Chief of Tehran Office

- c. Have graduated with a university degree and, if selected, must commence the internship within a one-year period of graduation.

Be computer literate in standard software applications. Have demonstrated keen interest in the work of the United Nations and have a personal commitment to the ideals of the Charter; have demonstrated ability to successfully interact with individuals of different cultural backgrounds and beliefs, which include willingness to try and understand and be tolerant of differing opinions and views. Preferred area of study: Studies in Urban Management, Urban/Municipal Planning, Geography, Environmental Management, Civil Engineering or Architecture is required.

Work Experience

Applicants are not required to have professional work experience for participation in the programme.

Languages

English and French are the working languages of the United Nations Secretariat. For this internship, fluency in oral and written English and Persian is required. Knowledge of another UN Language is desirable.
